TERMS AND CONDITIONS OF AGREEMENT

Customer agrees to purchase the equipment and wireless plan per the above specification and following terms and conditions:

Programming: The equipment will be initially programmed for the Processor specified by Customer (as listed above). Any reprogramming of the equipment from the initial programming (i.e. change of processor) by National ATM Wholesale will be the sole cost of Customer which will be at the then current Activation Charge plus Shipping and Handling. Customer represents and warrants that it has the right and power to enter into this Agreement

Changes to Services: National ATM Wholesale reserves the right to modify the services provided during the term of this Agreement.

Term: The initial term of this Agreement shall be twelve (12) months and shall commence upon the date hereof and shall be automatically renewed after the initial term for successive twelve (12) months terms; provided, however, that either party may, by giving the other party thirty (30) days prior written notice.

Payment of Charges: The total equipment purchase amount (including sales tax, shipping and handling), activation charge, first month's wireless rate charge (whether a full or partial month) and Extended Maintenance Plan (if desired) is due prior to shipping equipment to Customer. Monthly amounts due for wireless rate charge and equipment Extended Maintenance Plan are determined on a calendar month basis (whether a full or partial month) and will be assessed before the 5th calendar day of each month for the current month's service. Beginning with the second month's wireless rate charge and Extended Maintenance Plan (if desired) will be ACH'd from Customer's checking account per an ACH Agreement provided by Customer. Customer shall provide National ATM Wholesale written notice of any changes to banking account for ACH purposes. In the event that an ACH is returned unpaid to National ATM Wholesale, Customer agrees to pay a returned ACH fee of \$25.00 per returned item.

Legal: Customer represents and warrants that it has the right and power to enter into this Agreement. National ATM Wholesale's sole liability to Customer shall be to remedy any breach of this Agreement in a timely manner. National ATM Wholesale shall not be liable for any losses, expenses or costs incurred by Customer or others due to breakdown or malfunction of the equipment. In any dispute between the parties, whether or not resulting in litigation, the prevailing party shall be entitled to recover from the other party all reasonable costs including, without limitation, reasonable attorney's fees. The prevailing party shall include, without limitation, a party who dismisses an action for recovery in exchange for sums allegedly due, performance for covenants allegedly breached or consideration substantially equal to the relief sought in the action. This Agreement shall be construed, interpreted and enforced in accordance with the laws of the State of Utah. The jurisdiction and venue for any legal proceeding to interpret or enforce this Agreement shall be in Davis County, Utah.

Notice: Any notice required by the terms of this Agreement shall be given in writing and shall be deemed effective upon personal delivery or upon deposit with the appropriate postal service, by registered or certified mail with postage and fees prepaid and addressed to the party entitled to such notice at the address set forth above, or at such other address as such party may designate by 10 days' advance written notice to the other party to this Agreement.
